

Well, 2020 turned out to be the "year worth forgetting". The pandemic closed the VA Facilities to outside activities



and all visitors, severely curtailing our support. Perhaps like the some of the old numbering systems (hotels not having a 13th floor), we can skip 2020 and go from 2019 right to 2021.

In any case, our responsibilities remained unchanged, and we searched for different ways to support our veterans at this facility.

Normal support, such as monthly bingo, visiting with the veterans and other forms of on-site support were halted. We are hoping for things to loosen up so we can do our Christmas event at the hospital. The patients look forward to these events, but their safety must come first.

One bright light over the past year was our ability to facilitate the donation from the Department of WA to

provide the Seattle VA Hospital Common Room a brand new 86" LED TV and mount to replace their old 55". Now patients can view TV from all over the room and remain socially distant. The old TV was repurposed to a room that formally had no TV at all.

Overall, we remain in touch with the staff at the hospital and anxiously await clearance to resume our support activities there. It has been reported by hospital staff that the patients sorely miss our activities.

In addition to direct hospital support, we continue to support veterans by helping to transport them to and from appointments and by providing personal methods of transportation such as wheelchairs and other needed conveyances. We also continue to provide indirect support such as blood donations.

As we move toward the (hopefully) reopening of the Hospital for events such as bingo, I am asking for volunteers to help with the bingo. The patients really look forward to this activity. We need 4 to 5 volunteers to help call the numbers and assist the vets who may not be able to work the cards, as well as volunteers to serve some refreshments. Bingo is a small diversion, but an extremely pleasant experience for our veterans and for those volunteering to help. Please contact me at r.klug@comcast.net if you are interested.

Bingo is a once per month event, usually held on the 2nd Sunday (subject to change) of the month between 1300 and 1430 (average).

## Honor Guard

### **Scott Eliason**

The Post has maintained an Honor Guard to present final Military Honors for veterans at least since the forming of



the Panther Lake Post 11329 in 1991. The Kent Post 6785 and 11329 merged in 2008, continuing as Post 6785. Kent Post 6785 was reconstituted in 1978 but is not thought to have had its own honor guard. The Post has been providing Honors at Tahoma National Cemetery since it opened on 1 Oct 1997. Construction of the National Cemetery had started in 1993.

Our commitment to Tahoma National Cemetery is currently to provide Honors services on the first and second Thursday of each month. We share the duty day with the Kent Disabled American Veterans (DAV). DAV works mornings and we take the afternoons, most times. If there are only a few services, then DAV takes the first Thursday and 6785 does the second Thursday.

In April the Post was represented cumulatively by 23 members and provided 28 military honors. A total of 68 hours of member time was spent and members drove a total of 338 miles during the month. A large percentage of all honors this past month are the result of the efforts of Gary Smith.

One of our members, Gary Smith, tries to be available for all Navy services, and pipes remains aboard as the service starts and again as the remains are removed. He wears his Navy uniform and performs Bos'ns duties.

In February of this year the Honor Guard did a service for a veteran interred at Bonney-Watson, just east of SeaTac Airport, and we get calls for services away from Tahoma pretty regularly.

The Post maintains a budget line for the Honor Guard which underwrites the costs of uniform items and other expenses. The funds come largely from donations from families of the veterans and some from funeral homes. The Post Honor Guard fund either provides or reimburses for the jacket, and provides shirts, neckties, patches, pins and other accoutrements, garrison caps and a broadbrimmed hat. Shoes, socks, and gray trousers are considered personal items and the member provides them.

We can always use new members young and older, men and women, especially as some of us old coots get older. Even if you are still in the workforce, many of the services we are asked to provide are on weekends. Many of our members also serve when we need Color Guards, or other ceremonial events, such as parades and the Tahoma Memorial Day and Veterans Day celebrations. The Post Honor Guard Needs YOU! The Puget Sound area is experiencing critical blood shortages caused by the COVID pandemic. Local blood banks have sent out emergency requests for donors. Type 0 blood is especially needed. In many cases blood banks have less than a 24 hour of blood to be



used for patients. Now is the time for those of us who stepped up in the past to serve our country, to again roll up our sleeves. This time to give up a pint of the red stuff.

The good news is that donating blood in the era of COVId is perfectly safe. The blood banks are zealous in protecting the blood supply and doners. Blood banks no longer allow walk-ins so it's imperative that donors schedule appointments. Also noteworthy is that blood banks have streamlined the donor review process. You can now fill out the required questionnaire on-line on the day of donation and voila, you save ten minutes right off the bat.



Even better yet, the goodies given at the conclusion of the blood donation are still available. I gotta admit the post-donation snacks are my favorite part of donating blood. In fact, truth be known, I always smuggle out a cookie for two for my wife, after all it is her cooking which make me

so vibrant. As I drive off into the sunset after donating, I often wonder about the lucky person who going to receive my blood. First, let's talk a little about the Home page – as of the time I am writing this, the Home pages look like:



The Home page is updated with content whenever I get information that is worth posting. While the viewer can scroll down and see historical posts, the latest is always front and center. If you have something you would like to have posted on the home page, just send me any images and any write up you have about the post, and I can put it online for you. We can link to videos or pictures or just post text — whatever gets your point across. It does not just have to be events either — we can celebrate activities, wins, and any information that members might find useful.

The menu on the right-hand side rarely changes and is where you can sign up for email notifications, so you will get notified when new home page updates are made.

The Menu is a good place to spend some time exploring. This is where all kinds of pages exist to provide information and direction about different post activities and people. I try my best to keep it updated, but please let me know if you find outdated information that needs to be updated.

One Menu item you might find useful, is the member document page.

If it is your first time visiting the member document page, it will ask for a password. Once the password is entered you will be taken to the Documents page.

The Page is divided into two sections, Post Documents and Historical Documents.

The Post Documents section lists forms and documents that are reused by post members – like Expense report Vouchers.
